

Good Shepherd Lutheran School *Tuition Assistance Application*

The Tuition Assistance Program provides opportunity for a Christian School education for those who would otherwise not be able to afford the full cost of tuition. Assistance is based on income-related need, with specific amounts determined by the total funds available for the year. These funds are not a separate account, but are an operating loss in the school budget.

Since the tuition assistance program is a needs-based program, and because of limited available funds, those applying must supply accurate family income information. Any family in need is invited to apply. To apply for tuition assistance, you must submit this application in its entirety, along with a copy of your most recent tax returns. The information submitted will be kept confidential and will be reviewed by the Tuition Assistance Committee.

Please fill out the following information and attach the necessary documents (photocopies only please) and return to Good Shepherd Lutheran Church & School, 2101 Lor Ray Dr., North Mankato, MN, 56003. Incomplete applications and applications that do not include the required forms of proof of income will not be considered.

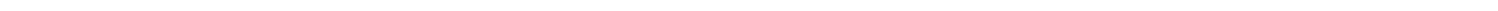

Application for tuition assistance is (check the one that is applicable):

- For Level 1: \$2175 in tuition assistance if you make \$30,000 or less and you MUST pay a minimum of \$25 per child each month. You MUST also volunteer at least 10 hours each month at Good Shepherd Lutheran School.**
- For Level 2: \$1500 in tuition assistance if you make \$45,000 or less and you MUST pay a minimum of \$100 per child each month. You MUST also volunteer at least 5 hours each month at Good Shepherd Lutheran School.**
- For Level 3: \$1050 in tuition assistance if you make \$60,000 or less and you MUST pay a minimum of \$150 per child each month. You MUST also volunteer at least 5 hours each month at Good Shepherd Lutheran School.**
- For Level 4: \$600 in tuition assistance if you make \$75,000 or less and you MUST pay a minimum of \$200 per child each month. You MUST also volunteer at least 3 hours each month at Good Shepherd Lutheran School.**

If you do receive financial assistance, you must abide by the terms of whichever level you are awarded. If you fail to do so, you may lose your tuition assistance. Incomplete applications that do not include the required forms will not be considered.
